# GOVERNMENT OF SINDH

## EXCISE & TAXATION DEPARTMENT.

### NOTIFICATION

NO:SO.T-I(E&T)1(113)90-Tax. In exercise of the powers conferred by section 11 read with sub-section (2) of section 8 of the Sindh Finance Act, 1990, the Government of Sindh are pleased to make the following rules, namely:-

1. (1) These rules may be called the Sindh Video Film Dealer Licence Rules, 1990. **Short title and commencement.**

(2) They shall come into force atonce.

2. In these rules, unless there is anything repugnant in the subject or context :- **Definition**

(a) "Act" means the Sindh Finance Act, 1990;

(b) "Form" means a form appended to these rules;

(c) "Licence" means a Licence issued under rule 6;

(d) "Licencee" means a person who has been granted a licence;

(e) "Licensing Authority" means the Director, Excise & Taxation, in whose jurisdiction the place of business of a video film dealer is situated and includes any officer appointed by Government to exercise the powers of the licensing authority under these rules.

3. (1) Any person intending to engage himself in or to carry on the business of video films dealer shall apply for a licence to the licensing authority in form 'A'. **Application for Licence.**

(2) Any person who was engaged in or was carrying on the business immediately before the commencement of these rules and desires to continue the business, shall apply rules and shall carry on the business until his application for licence is decided or if appeal is preferred against rejection of his application until the decision of the appeal.

(3) Any application for a licence shall accompanied by the fees prescribed by the Act.

(4) The licensing authority may, on receipt of the application, make such enquiries as deemed fit.

(5) Where the application is rejected, the licence fee received with the

application shall be refunded to the application within a period of thirty days from date on which his application is rejected or if appeal is preferred under these rules on rejection of the appeal.

4. No person shall be granted a licence if he :-

- (a) is a minor, or insane person;
- (b) is found to be of unsonund mind by a court of competent jurisdiction;
- (c) is declared insolvent.

**Certain persons  
not to be  
granted licence.**

5. The licensing authority on being satisfied that the applicant does not suffer from any of the disqualifications mentioned in these rules, shall grant him a licence in form 'B' which shall be registered in a register in form 'C'.

6. A licence shall :-

- (a) not deal in any such video film which has been banned for exhibition by the authorities concerned or is otherwise prejudicial to decency or morality.
- (b) Afford necessary facilities to the licensing authority or any officer authorised by it in this behalf to inspect the shop premises and records.
- (c) On deemed produce the licence for inspection.
- (d) Display the licence at a conspicuous place of the premises of his shop.
- (e) Comply with the provisions of these rules or such other instructions as may be given by the licensing authority in accordance with the Act of these rules.

**Conditions of  
licence.**

7. (1) A licence shall be valid for a period of one year which shall be renewable for the same period on payment of the fees prescribed by the Act.

**Renewal of  
licence.**

(2) Application for renewal of licence accompanied by the prescribed fee shall be made in Form 'D' not later than thirty days proceeding the date on which the validity of the licence is due to expire.

8. If the licensee fails to obtain a licence or apply for the renewal of his licence in accordance with rule 7 and continues to carry on his business after the date on which the validity of his licence expires he shall be liable to the penalty provided in the Act.

**Penalty**

9. In the case of his-continuance or transfer of the business, the licensee shall inform the licensing authority within thirty days of such dis-continuance or transfer, and the licensing authority shall, on receipt of such information, cancel or, as the case may be, issue a new licence to the transferee.

**Dis-continuance  
of the business.**

10. If at any time the licensing authority is satisfied that a licensee has violated any provision of these rules or has committed any breach of the conditions of the licence, it may by order in writing suspend the licence for such period not exceeding three months as may be specified in the order, or cancel it;

**Suspension or  
cancellation of  
licence.**

Provided that no such order shall be passed unless the person concerned has been given reasonable opportunity of showing cause.

11. The licensee if aggrieved by any order passed by the licensing authority under these rules may, within thirty days from the date of such order, prefer an appeal to the Director General, Excise and Taxation and the order passed by the Director General shall be final.
