An Ordinance further to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient further to amend the Provincial Motor Vehicles Ordinance, 1965, in the manner hereinafter appearing; Preamble.

AND WHEREAS the Provincial Assembly stands suspended in pursuance of the proclamation of the fourteenth day of October, 1999, and the Provisional Constitution Order No. I of 1999;

AND WHEREAS the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in Pursuance of the aforesaid Proclamation and the Provisional Constitution Order read with Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Provincial Motor Vehicles (Amendment) Ordinance, 2000. **Short title and commencement.**
(2) it shall come into force at once.

2. In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, for section 116-A, the following shall be substituted:- **Substitution of section 116-A to W.P. Ord. XIX of 1965.**

"116-A Ticket system-(1) In any area to which Government has notification in the official Gazette, applied the provisions of this section, a police officer in uniform, not below the rank of a Head Constable, may notwithstanding anything to the contrary contained in this Ordinance, or in any other law for the time being in force, charge on the spot any person committing within his view an offence mentioned in the Twelfth Schedule in respect of a motor vehicle.

(2) A police officer acting under sub-section (1), shall draw up a charge sheet in quadruplicate, in form J, as set forth in the First Schedule, and shall---

 - (a) forthwith deliver one copy thereof to the offender, who shall acknowledge its receipt under his signature or thumb impression, as the case may be;
 - (b) within twenty four hours forward the second copy of the charge sheet to the court having jurisdiction to try the offence;
 - (c) within twenty four hours forward the third copy of the charge sheet to the charge to the prescribed agency where the offenders has to deposit the fine; and

- (d) Retain the fourth copy for record.
- (3) A person charged with an offence under this section shall, if he does not want to contest the charge, pay, within seven days from the date of delivery of the charge sheet to him under sub-section (2), the penalty specified for the offence mentioned in the charge sheet through cash in any branch of the National Bank of Pakistan under intimation to the concerned police officer or police station specified therein.
- (4) Where a person charged pleads guilty and pays the prescribed fine and has complied with the provisions of sub-section (3) no further action shall be taken against him in respect of the offence.
- (5) If the fine is not paid in the manner provided in sub-section (3), the police officer drawing up the charge shall lay a complaint against the offender before the court, having jurisdiction to try the offence.
- (6) Government may by notification amend the Twelfth Schedule so as to add any new entry thereto or modify or omit any existing entry therefrom."

3. In the said Ordinance, in the First Schedule

- (a) for "From J" the From specified in Appendix I to this Ordinance shall be substituted; and
- (b) the "From K" shall be deleted.
