

SIND ORDINANCE NO. VII OF 1976

THE PROVINCIAL MOTOR VEHICLES (SIND AMENDMENT) ORDINANCE, 1976

[26th October, 1976]

An Ordinance further to amend the Provincial Motor Vehicles Ordinance, 1965, in its application to the Province of Sind.

WHEREAS it is expedient further to amend the Provincial Motor Vehicles Ordinance, 1965, in its application to the Province of Sind, in the manner hereinafter appearing;

Preamble.

AND WHEREAS the Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance :-

1. (1) This Ordinance may be called the Provincial Motor Vehicles (Sind Amendment) Ordinance, 1976.

Short title and commencement.

(2) It shall come into force at once.

2. In the Provincial Motor Vehicles Ordinance, 1965, in its application to the Province of Sind, in section 50, in clause (a) of sub-section (1), for the words "eight thousand", the words "fifteen thousand", shall be substituted.

Amendment of section 50 of West Pakistan Ordinance XIX of 1965.

3. In the said Ordinance, in section 67—

(a) in sub-section (1), between the word "carriage" and the word "as", the words "or by the Corporation if such carriage belongs to the Corporation" shall be inserted;

(b) in clause (a) of sub-section (1), for the words "eight thousand", the words "fifteen thousand" shall be substituted.

4. In the said Ordinance, in the Sixth Schedule, after the last entry before note 1, the following shall be added :-

Sr. No.	Injury	Compensation Rs.
1.	Loss of right arm above or at the elbow	4,000
2.	Loss of left arm above or at the elbow	4,000
3.	Loss of right arm below the elbow	3,500
4.	Loss of left arm below the elbow	3,500
5.	Loss of leg at or above the knee	4,000
6.	Loss of leg below the knee	3,500
7.	Permanent loss of hearing	4,000
8.	Loss of one eye	4,500
9.	Loss of both eyes	8,000
10.	Loss of thumb	2,000
11.	Loss of toes on one foot	3,000
12.	Loss of index finger	2,000
13.	Loss of great toe	1,500
14.	Loss of any finger other than index finger	1,500
15.	Permanent disfiguration of face or head	1,500 to 4,000 on the gravity of the disfiguration.
16.	Fracture or dislocation of a bone	1,500
17.	Emasculation	3,500
18.	Loss of one or more teeth	500 for one, for more 2,000

Note:-- Maximum compensation payable for more than one injury shall be limited to rupees ten thousand.".
