**THE SIND AGRICULTURE UNIVERSITY (AMENDMENT)
ORDINANCE, 1986.**

[30TH July ,1986.]

An ordinance to amend the Sind Agriculture University Act, 1977.

WHEREAS it is expedient to amend the Sind Agriculture University Act, 1977, in the manner hereinafter appearing; **Preamble.**

AND WHEREAS the Provincial Assembly is not in session and the Governor of Sind is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sind is pleased to make and promulgate the following Ordinance:-

1. (1) This Ordinance may be called the Sind Agriculture University (Amendment) Ordinance, 1986. **Short title and commencement.**
(2) It shall come into force at once.
2. In the Sind Agriculture University Act, 1977, hereinafter referred to as the said Act, in section 2, after clause (i), the following shall be inserted:- **Amendment of section 2 of Sind Act, V of 1977.**
“(ii) “Pro-Vice-Chancellor” means the Pro-Voice Chancellor of the University;”.
3. In the said Act, in section 15, in sub-section (1), after clause (i), the following shall be inserted:- **Amendment of section 15 of Sind Act, V of 1977.**
“(i-a) the Pro-Vice-Chancellor;”.
4. In the said Act, in section 17, in sub-section (1), after clause (i), the following shall be inserted:- **Amendment of section 17 of Sind Act, V of 1977.**
“(i-a) the Pro-Vice-Chancellor;”.

5. In the said Act, in section 26, after clause (i), the following shall be inserted:-

Amendment of section 26 of Sind Act, V of 1977.

“(i-a) the Pro-Vice-Chancellor;”.

6. In the said Act, after section 28, the following shall be inserted:-

Insertion of section 28-A in Sind Act V of 1977.

“Pro-Vice-Chancellor.

”28 -A. (1) The Chancellor may in consultation with the Vice-Chancellor, appoint a Pro-Vice-Chancellor for the main campus or for additional campus, if any, for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at a time as the Chancellor may determine.

(2) Where a Pro-Vice Chancellor is appointed under sub-section (1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice-Chancellor or such other powers and functions, in respect of the campus for which he is appointed as the Chancellor may delegate to him.”.
