THE PROVINCIAL MOTOR VEHICLES (AMENDMENT) ORDINANCE, 2008.

[17th March, 2008]

An Ordinance to amend the Provincial Motor Vehicles Ordinance, 1965. **Preamble.**

WHEREAS it is expedient to amend the Provincial Motor Vehicles Ordinance, 1965. in the manner hereinafter appearing:

AND WHEREAS the provincial Assembly is not in session and the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action.

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sindh is pleased to make and promulgate the following Ordinance:-

In the Provincial Motor Vehicles Ordinance, 1965, hereinafter referred to as the said Ordinance, for section 112, the following shall be substituted:-

"112 Whoever contravenes any provision of this Ordinance, or the rules made thereunder shall, if no other penalty is provided for the offence under this Ordinance, be punished with fine as mentioned in Twelfth Schedule.

112-A Whoever drives a motor vehicle and displays a revolving or an emergency light, fabricates or counterfeits a distinctive sign or mark in a motor vehicle in violation of the provisions of this Ordinance, the rules or a notification issued by government shall be punished with fine as mentioned in Twelfth Schedule and the unauthorized articles shall be confiscated.". | substituted of section 112 of west Pakistan Ordinance No. XIX of 1965.
