

SINDH ACT NO.I OF 2009
THE SINDH PUBLIC PROPERTY (REMOVAL OF ENCROACHMENT) (AMENDMENT)
ACT, 2008

[29th January, 2009]

An Act to further amend the Sind Public Property (Removal of Encroachment) Act, 1975.

WHEREAS it is expedient to further amend the Sind Public Property (Removal of Encroachment) Act, 1975, in the manner hereinafter appearing;

Preamble

It is hereby enacted as follows: -

1. (1) This Act may be called the Sindh Public Property (Removal of Encroachment) (Amendment) Act, 2008.

Short title and commencement.

(2) It shall come into force at once.

2. In the Sind Public Property (Removal of Encroachment) Act, 1975, hereinafter called the said Act, in section 2, for clause (f). the following shall be substituted :-

"(f) "Council" means a Council as defined in the Sindh Local Government Ordinance, 2001."

3. Through out the Act, for the words "Local Council", the word "Council" shall be substituted.

4. In the said Act, in section 3, in sub-section (1), for the words "three days", the words "two days" shall be substituted.

5. In the said Act, in section 4, in sub-section (1), for the words "seven days", the words "three days" shall be substituted.

6. In the said Act, in section 5, in sub-section (1), for the words "seven days", the words "three days" shall be substituted.

7. In the said Act, in section 8, for sub-section (1), the following shall be substituted :-

"(1) Any person responsible for encroachment, may be punished with imprisonment of either description for a term which may extend to five years but not less than one year and with fine which may extend to five lac rupees. "

8. In the said Act, after section 15, the following new section shall be inserted:- [Insertion of section 15-A.](#)

"15-A. Government may for the prevention of encroachment on public property and to enforce the provisions of the Act, establish an Anti-Encroachment Force in the prescribed manner." [Establishment of Anti-Encroachment Force.](#)

9. In the said Act, after section 17, the following shall be added:- [Addition of section 18 in the Sind Act No.V of 1975.](#)

"18. The provisions of this Act shall have over-riding effect notwithstanding anything contained in any other law for time being in force." [Act to over-ride other laws.](#)
