

SINDH ORDINANCE NO.VIII OF 1990

**THE SINDH EMPLOYEES SPECIAL ALLOWANCE (PAYMENT)
(AMENDMENT) ORDINANCE, 1990.**

[31st December, 1990]

An Ordinance further TO amend the Sind Employees Special Allowance (Payment) Act, 1986.

WHEREAS it is expedient to amend the Sind Employees Special Allowance (Payment) Act, 1986, in the manner hereinafter appearing; **Preamble.**

AND WHEREAS the Provincial Assembly is not in session and the Governor of Sindh is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of Sindh is pleased to make and promulgate the following Ordinance:—

1. (1) This Ordinance may be called the Sindh Employees Special Allowance (Payment) Ordinance, 1990.

Short title and commencement.

(2) It shall come into force at once and shall be deemed to have taken effect on and from 1st day of December, 1990.

2. In the Sind Employees Special Allowance (Payment) Act, 1986, hereinafter referred to as the SAID Act, after the words "special allowance" wherever occurring, the words "and additional special allowance" shall be added.

Amendment in Sind Act X of 1986.

3. In the said Act, after section 3, the following new section 3-A shall be added:—

Insertion of section 3-A of Sind Act X of 1986.

"3-A. Every employee whose wages do not exceed two thousand five hundred and eighty five rupees per month shall in respect of his employment on or after the 1st day of December, 1990, be paid by his employer on additional special allowance—

- (a) Equal to two hundred rupees per month, if his wages do not exceed two thousand five hundred and eighty five rupees per month; or
- (b) At such rate as, together with his wages, makes a total of two thousand seven hundred and eighty five rupees per month, if his wages are more than two thousand five hundred and eighty five rupees per month:

Provided that the additional special allowance shall be set off against the amounts payable_____

- (a) As a relief due to rise in the cost of living under an agreement or settlement reached, or an award given, under the Industrial Relations Ordinance, 1969, on or after 1st December, 1990; and
- (b) Under an agreement or settlement reached and in force on the first day of December, 1990 under which the employees get increase at regular intervals on the basis of rise in the cost of living".
