[18<sup>th</sup> November, 1882]

An Act to provide for the levy of fees for the use of Public Landing-places.

**WHEREAS** it is expedient to provide for the levy of fees for the use of public landing-places in certain ports in the <sup>2</sup>[Province of Sind]; It is hereby enacted as follows :---

**Preamble.**

1. This Act shall be called "the <sup>3</sup>[Sind] Landing and wharfage Fees Act, 1882."

**Short title.**

2. <sup>4</sup>[It shall extend to any ports] in the <sup>5</sup>[Province of Sind] to which <sup>6</sup>[Government] may from time to time, by <sup>7</sup>notification and the <sup>8</sup>[Official Gazette], extend the Act.

**Local extent.**

4. In this Act <sup>9</sup>[the term "Government" <sup>10</sup>[\* \* \* \* \*]] means the Provincial Government; the <sup>4</sup>[term "landing-place" includes a bandar, wharf, pier, jetty, hard and any place used for the landing, shipping, or storage of goods, or for the embarking or disembarking of passengers] :

<sup>2</sup>[and the term "passengers" means any person of three years of age or upwards, carried in a vessel, other than the master and crew and the owner, his family and servants.]

5. It shall be lawful for <sup>3</sup>[Government] from time to time by notification in the <sup>4</sup>[Official Gazette]---

**Government to fix limits of bandars, etc., and the fees to be levied.**

(a) to define the limits of any port to which this Act is made applicable when such limits have not been defined under the <sup>5</sup>[Ports Act, 1908];

(b) to determine what are public landing-places to which the provisions of this Act shall apply;

(c) to determine the limits of any such landing-places;

(d) to withdraw this Act from any port in which it is for the time being in force;

(e) to fix the fees to be levied---

(1) on goods landed, shipped or stored at, and

(2) on passengers embarking or disembarking at, and

(3) on animals or vehicles bringing or removing goods to or from, or plying for hire at, and

(4) on vessels or boats approaching or lying along-side any such landing-place ;

<sup>7</sup>[Provided that it shall be lawful for <sup>3</sup>[Government] at any time to exempt any goods, passengers, vessel, boat, animal or vehicle wholly or partially from any fee to which the same may be liable under this section;]

<sup>7</sup>[provided further that the fee to be levied on any passenger on each occasion of embarking or disembarking at a landing-place shall not exceed <sup>8</sup>[six paisa].]

6. The levy of fees under this Act shall be made and all other powers and duties conferred and imposed by this Act or by any bye-laws made hereunder, shall be exercised and performed by such officers as <sup>1</sup>[Government] shall from time to time direct, or by such persons as <sup>2</sup>[it] shall from time to time direct in this behalf.

**Powers and duties under this Act by whom to be exercised and performed.**

7. The officers and persons whose duty it may be to levy fees under this Act shall have the same powers for collecting and enforcing payment of the same as are exercisable under the provisions of any law, for the time being in force, in respect of duties of sea customs by the Collector of Customs and his subordinates, and shall have the same privileges and be subject to the same liabilities in have the same privileges and be subject to the same liabilities in respect of anything done by them in collecting and enforcing payment of the said fees as the said Collector of Customs and his sub-ordinates have, or are liable to, under the provisions of any such law.

**Powers privileges and liabilities of officers who collect fees.**

The law for the time being in force for the punishment of offences relating to the levy or payment of duties of sea-customs, and for the reward of informers, shall, as far as may be, apply to similar offences committed in respect of the said fees.

**Punishment of offenders.**

<sup>3</sup>[In particular and without prejudice to the generality to the generality of the provisions of the foregoing paragraph, the penalty prescribed in the third column of article I of section 167 of the <sup>4</sup>Sea Customs Act, 1878, shall be leviable in respect of the contravention of any bye-law made under this Act.]

8. Tables of the fees leviable under this Act shall be posted up in some conspicuous position at every landing-place at which such fees are leviable, in English and the Vernacular language of the district, province, or territory in which the port is situate.

**Tables of fees to be posted up.**

9. <sup>5</sup>[The] <sup>6</sup>[Chief Customs-authority] may, with the previous sanction of Government, from time to time make, and from time to time alter or repeal, bye-laws not inconsistent with the provisions of this Act :

**Powers to make bye-laws.**

(b) providing for the management of the traffic over, on or about and to and from every such landing-place;

<sup>1</sup>[(c) regulating the collection and remittance of the fees leviable under all or any of the provisions of this Act; and]

<sup>2</sup>[(d)] generally for the guidance of all persons in matters connected with the enforcement of this Act.

The bye-laws so made, and every alteration of the same and every order repealing the same or any portion thereof, shall be published in the <sup>3</sup>[Official Gazette].

<sup>4</sup>[10. <sup>5</sup>[In any port to which this Act applies expenditure incurred under any of the following heads shall be deemed for the purposes of the next succeeding section to be expenditure under this Act, for the port, that is to say, expenditure---

**Fees realized under this Act how to be expended.**

(a) in payment of the expenses of the administration of this Act;

(b) in defraying the cost of acquiring or constructing new landing-places required for the convenience of the traffic or trade of such port;

(c) in maintaining and improving any existing landing-place and in constructing, maintaining or providing waiting rooms and other convenience or facilities for passengers, and generally in the improvement of such port; and

(d) in payment of the charges connected with the establishing, maintaining and working of telegraphs and telephones between any such ports;

<sup>6</sup>[11. (1) For each port to which this Act applies a distinct account, to be called the landing and wharfage fees fund account, shall be kept showing, in such detail as the Chief Customs-authority prescribes, the receipts and expenditure under this Act for the port.

An abstract of the account for the past financial year, in such form as the Chief Customs-authority prescribes, shall be published annually as soon after the first day of April as may be practicable.

(2) If an advance of money shall be made by the Government for any of the purpose of this Act, on account of any port to which this Act applies, simple interest on that advance or upon so much of it as shall remain unrepaid, at such rate as <sup>1</sup>[Government] may determine, shall be chargeable in the landing and wharfage fees fund account of such port.

(3) All monies received under this Act at or on account of any port to which this Act applies shall be credited in the landing and wharfage fees fund account of the port. **Grouping posts.**
