

**THE SIND ACT NO. V OF 1883<sup>1</sup>.**  
**[THE SIND PUBLIC AUTHORITIES SEALS ACT, 1883.]**

[5th November, 1883.]

An Act to enable Government to prescribe the Official Seals of Sessions Judges, Magistrates and other public authorities.

**WHEREAS** it is expedient <sup>2\*</sup> \* \* \* \* to enable the Government to prescribe what official seals <sup>2\*\*</sup> public authorities <sup>2\*</sup> \* shall have and use; It is enacted as follows :---

1. This Act may be called the <sup>3</sup>[Sind] Public Authorities Seals Act, 1883. **Short title.**

3. The <sup>4</sup>[Provincial Government], may, from time to time, by notification in the <sup>5</sup>[Official Gazette], direct what officials seals each of the following <sup>7\*</sup> \* \* \* \* public authorities shall have and use (namely) : ---

**Provincial Government empowered to prescribe the seals of certain public authorities.**

(1) Sessions Judges, Additional <sup>8</sup>[ \* \* \* ] Sessions Judges and Assistant Sessions Judges;

**[THE SIND PUBLIC AUTHORITIES SEALS ACT, 1883.]**

(4) any other judicial officer or public authority, whose official seal is not prescribed by law and no other authority is legally competent to prescribe.

Every such notification may from time to time be modified or rescinded by the <sup>1</sup>[Provincial Government] by a like notification.

4. Every notification made under the last preceding section shall come into force on such date as the <sup>1</sup>[Provincial Government] shall therein fix in this behalf.
