AN ACT to amend the Sindh Sports Board Ordinance, 1980.

WHEREAS it is expedient to amend the Sindh Sports Board **Preamble** Ordinance, 1980, in the manner hereinafter appearing;

It is hereby enacted as follows:-

Department not below the rank of Chief Planning Officer

- (viii) Deputy Secretary, Sports **Member** and Youth Affairs Department
- (ix) Director Sports, Sindh **Member**
- (x) Deputy Directors (Sports) **Member** of all Divisions
- (xi) Representative of Sindh **Member** Olympic Association
- (xii) Four Representatives of **Member** associations nominated by Government
- (xiii) Two Members of the **Members** Provincial Assembly of Sindh are to be nominated by the Speaker.
- (ii) after sub-section (1), the following shall be inserted:-

"(1-A) The Chairman or in his absence the Vice-Chairman shall preside over the meetings of the Board."
- (iii) for sub-section (2), the following shall be substituted:-

"(2) The Secretary, Sports and Youth Affairs Department and Director Sports shall be the Secretary and Joint Secretary of the Board, respectively.";
- (iv) in sub-section (2-A), for the word "Governor", the words "Chief Minister" shall be substituted.
