AN ACT to amend the Sindh Sports Board Ordinance, 1980.

WHEREAS it is expedient to amend the Sindh Sports Board Ordinance, 1980, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Sports Board (Amendment) Act, 2018. **Short title and commencement.**

(2) It shall come into force at once.
2. In the to amend the Sindh Sports Board Ordinance, 1980, hereinafter referred to as the said Act, in section 4- **Amendment of section 4 of Sindh Ordinance No.VIII of 1980.**
 - (i) for sub-section (1), the following shall be substituted:-

“(1) The Board shall consist of the following:-
 - (i) Chief Minister Sindh **Chairman**
 - (ii) Minister for Sports **Vice-Chairman**
 - (iii) Secretary, Sports and Youth Affairs **Member**
 - (iv) Secretary Finance or his nominee not below the rank of an Additional Secretary **Member**
 - (v) Commissioners of the all Divisions in Sindh **Members**
 - (vi) Secretary (Colleges), Education Department or his nominee not below the rank of an Additional Secretary **Member**
 - (vii) Representative of the Planning & Development **Member**

- (viii) Deputy Secretary, Sports and Youth Affairs Department **Member**
 - (ix) Director Sports, Sindh **Member**
 - (x) Deputy Directors (Sports) of all Divisions **Member**
 - (xi) Representative of Sindh Olympic Association **Member**
 - (xii) Four Representatives of associations nominated by Government **Member**
 - (xiii) Two Members of the Provincial Assembly of Sindh are to be nominated by the Speaker. **Members**
- (ii) after sub-section (1), the following shall be inserted:-
- "(1-A) The Chairman or in his absence the Vice-Chairman shall preside over the meetings of the Board."
- (iii) for sub-section (2), the following shall be substituted:-
- "(2) The Secretary, Sports and Youth Affairs Department and Director Sports shall be the Secretary and Joint Secretary of the Board, respectively.";
- (iv) in sub-section (2-A), for the word "Governor", the words "Chief Minister" shall be substituted.
