**WHEREAS** it is expedient to amend the Sindh Safe Cities Authority Act, 2019, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Safe Cities Authority (Amendment) Act, 2025. **Short title and commencement.**

(2) It shall come into force at once.

2. In the Sindh Safe Cities Authority Act, 2019, hereinafter referred to as the said Act, in section 1, sub-section (4) shall be omitted. **Amendment of section 1 of Sindh Act No. XXI of 2019.**

to amend the Sindh Safe Cities Authority Act, 2019.

**WHEREAS** it is expedient to amend the Sindh Safe Cities Authority Act, 2019, in the manner hereinafter appearing; **Preamble.**

It is hereby enacted as follows:-

1. (1) This Act may be called the Sindh Safe Cities Authority (Amendment) Act, 2025. **Short title and commencement.**

(2) It shall come into force at once.

2. In the Sindh Safe Cities Authority Act, 2019, hereinafter referred to as the said Act, in section 1, sub-section (4) shall be omitted. **Amendment of section 1 of Sindh Act No. XXI of 2019.**



3. In the said Act, Sindh Safe Cities Authority Act, 2019, in sub-section (2) – **Amendment of section 2 of Sindh Act No. XXI of 2019.**

(i) in clause (f), for the words “cities of Province as Government may specify under sub-section (4) of section 1”, the words “cities and towns of the Province” shall be substituted;”;

(ii) after clause (f) as amended above, the following new clause shall be inserted:-

“(ff) “Department” means the Home Department, Government of Sindh;”;

(iii) after clause (h), the following new clause shall be inserted:-

“(hh) “Executive Committee” means the Executive Committee constituted under this Act;”;

(iv) in clause (m), the word “and” shall be omitted;

(v) in clause (p), after the semi-colon appearing at the end, the word “and” shall be added;

(vi) after clause (p) as amended above, the following new clause shall be added:-

“(pp) “Project Director” means a Government Officer or any other person appointed by the Chief Secretary, Government of Sindh, to manage, supervise and oversee the implementation of a Safe City Project in a city or town;”.

4. In the said Act, in section 6 -

**Amendment of section 6 of Sindh Act No. XXI of 2019.**

(i) for the words “Management Committee”, wherever appearing including the margin, the words “Executive Committee” shall be substituted;

(ii) in sub-section (1) –

(a) in clause (iv), for the words “Secretary, Local Government Department”, the words “Chairman, Planning & Development Board” shall be substituted;

(b) for clause (iv), the following shall be substituted:-

“(iv) Director General, Member/Secretary;”;

(c) in clause (vi), for the words and figures “A representative of Finance Department (not below BS-19)”, the words “Secretary to Government of Sindh, Finance Department” shall be substituted;



(d) in clause (vii), for the words and figures "A representative of the Information, Science & Technology (not below BS-19)", the words "Secretary to Government of Sindh, Information, Science & Technology Department" shall be substituted;

(e) in clause (viii), for the words and figures "A representative of Excise, Taxation & Narcotics Control Department (not below BS-19)", the words "Project Director of Safe City Project of the concern city/Town" shall be substituted;

(f) in clause (ix), for the words "Member/Secretary", the word "Member" shall be substituted.

5. In the said Act, after section 6, the following new section shall be inserted:-

**"6-A, Management Committee.** (1) The Authority shall have the Management Committee, consisting of the following:-

(2) The Management Committee shall perform such functions in such manner as may be prescribed and until so prescribed, as the Authority may assign or determine."



6. In the said Act, in section 7, in sub-section (1), for the figures "20", the figures "19/20" shall be substituted. **Amendment of section 7 of Sindh Act No. XXI of 2019.**
7. In the said Act, in section 8, in sub-section (1), for the figures "19", the figures "18/19" shall be substituted. **Amendment of section 8 of Sindh Act No. XXI of 2019.**
