AN ACT to provide for establishment of the University known as the University of Larkano.

WHEREAS it is expedient to provide for the establishment of the University known as the University of Larkano and to provide for the matters connected therewith or ancillary thereto;

Preamble.

It is hereby enacted as follows:-

CHAPTER-I **PRELIMINARY**

1. (1) This Act may be called the University of Larkano Act, 2023. **Short title and commencement.**
(2) It shall come into force at once.
2. In this Act unless there is anything repugnant in the subject or context – **Definitions.**
 - (a) “Academic Council” means the Academic Council of the University;
 - (b) “affiliated college” means a college or an educational Institution affiliated to the University but not maintained or administered by it;
 - (c) “Authority” means any of the Authorities of the University specified in section 24;
 - (d) “Chancellor” means the Chancellor of the University;
 - (e) “Chairman” means the head of a Teaching department;
 - (f) “Chief Minister” means the Chief Minister of Sindh;
 - (g) “College” means a constituent college or an affiliated college;
 - (h) “Commission” means the Sindh Higher Education Commission established under the Sindh higher Education Commission Act, 2013 (Sindh Act No.XI of 2013);

- (i) “constituent college” means a college maintained and administered by the University;
- (j) “Dean” means the head of a Faculty;
- (k) “Director” means the head of teaching division or an Institute established as constituent institute by the University;
- (l) “educational institution” means an institution imparting instruction in a subject or subjects relating to a faculty;
- (m) “Faculty” means a Faculty of the University;
- (n) “Government” means the Government of Sindh;
- (o) “Higher Education Commission Pakistan” means the Commission established under Higher Education Commission Pakistan Ordinance 2002;
- (p) “Officer” means any of the officers of the University specified in section 9;
- (q) “prescribed” means prescribed by Statutes, Regulations or Rules;
- (r) “Principal” means the Head of a college;
- (s) “Pro-Chancellor” means the Pro-Chancellor of the University;
- (t) “Pro Vice-Chancellor” means the Pro Vice-Chancellor of the University;
- (u) “Professor Emeritus” means a retired Professor working in the University in an honorary capacity;
- (v) “registered graduate” means –
- (i) A graduate of the University who has his name entered in the register maintained for his purpose; or

- (ii) A graduate of any other University who ordinarily resides within the territorial jurisdiction of the University and has his name entered in the register maintained by the University for this purpose;
- (w) “Registrar” means the Registrar of the University;
- (x) “Research Officer” means a person engaged whole-time by the University for research and equivalent in rank to a university Teacher;
- (y) “Search Committee” means the Search Committee constituted under the Constitution of the Search Committee Act, 2022 (Sindh Act No.II of 2022);
- (z) “Senate” means the Senate of the University;
- (aa) “Statutes” “Regulations” and “Rules” mean respectively the Statutes. Regulations and Rules made or deemed to have been made under his Act;
- (bb) “Syndicate: means the Syndicate of the University;
- (cc) “Teachers” Include Professor, Associate Professors, Assistant Professors and Lecturers engaged whole-time by the University or by the college for teaching degree, honours or post-graduate classes, and such other persons as may be declared to be Teachers by Regulations;
- (dd) “Teaching Department” means a Teaching Department established and maintained, or recognized by the University;
- (ee) “University” means the University of Larkano;
- (ff) “Vice-Chancellor”, means the Vice-Chancellor of the University;
- (gg) “Visiting teacher” means a teacher who is invited for teaching by the University for a short period.

CHAPTER-II THE UNIVERSITY

3. (1) The University to be a called the University of Larkano, is **Incorporation.**
established in accordance with the provisions of this Act.

(2) The University shall consist of-

- (i) the Chancellor;
- (ii) the Chief Minister;
- (iii) the Pro-Chancellor;
- (iv) the Vice-Chancellor;
- (v) the Pro-Vice Chancellor, Deans, Principals of the Chairman of Teaching Departments, Registrar, Director Finance, Deputy Director Finance, Resident Auditor, Controller of Examinations, Project Director, Director Planning and such other officers as may be prescribed;
- (vi) the members of the Senate, the syndicate, the Academic Council and other Authorities of the University;
- (vii) all University teachers; and
- (viii) Professors Emeritus;

Provided that the Chief Minister may set up in any educational institution or college under the control and management of the University and establish a Board of Governors under section 42, in lieu of the Officers and employees at the educational institution or college.

(3) The University shall be a body corporate having perpetual succession and a common seal with power among others, to acquire, hold and dispose of any property both movable & immovable vesting in it and shall by the aforesaid name sue and be sued.

(4) The University shall be competent to acquire and hold property, both movable and immovable, or lease, sell or otherwise transfer any moveable and immovable property which may have vested in or been acquired by it or enter into contract for the purpose of this Act.

4. (1) All properties and assets, right and interest of whatever kind, used enjoyed, possessed, owned or vested in or held in trust by the constituent college/campus of Quaid-e-Awam University of Engineering, Science and Technology at Larkana, Shaheed Zulfikar Ali Bhutto Agriculture College Dokri, Shaheed Benazir Bhutto Law College, Larkano, and constituent campus of Sindh University at Larkana, and all liabilities legally subsisting against them immediately before the commencement of this Act, shall stand transferred to the University. **Assets and Liabilities and Transfer of Staff**
- (2) All persons serving in the constituent college/ campus of Quaid-e-Awam University of Engineering, Science and Technology at Larkana, Shaheed Zulfikar Ali Bhutto Agriculture College Dokri, Shaheed Benazir Bhutto Law College, Larkano and constituent campus of Sindh University at Larkana, Jamshoro in any capacity immediately before the commencement of this Act, shall, notwithstanding any law or terms and conditions of their service, stand transferred for service to the University on the terms and conditions as may be prescribed.
- Provided that such terms and conditions shall not be less favourable than the terms and conditions admissible to them immediately before their transfer.
- (3) Any person transferred to the University under the sub-section (2) including the person who is transferred but has not so far reported to the University may opt to serve the relevant Department of Government or the University or College administering their services.
- (4) The option under sub-section (3) shall be exercised and submitted to relevant Department of Government or the University or College administering their services, within ninety days of the commencement of this Act, and the option so exercised shall be final.
- (5) On receipt of the option under sub-section (3), relevant Department of Government or the University or College administering their services, may transfer or, as the case may be, allow to continue the person concerned for further service in the relevant Department of Government or the University or College administering their services.

5. The University shall have the powers-
- Powers of the University.**
- (i) to provide for instructions in such branches of learning as it may deem fit and to make provision for research and for the advancement and dissemination of knowledge in such manner as it may determine;
 - (ii) to prescribe courses of studies to be taught or conducted in the University and colleges;
 - (iii) to hold examinations and confer degrees for graduate and post graduate, diplomas, certificates and other academic distinction on person who have, under the prescribed conditions have been admitted to and passed its examinations under prescribed conditions;
 - (iv) to confer honorary degrees or other academic distinctions on such persons in the prescribed manner;
 - (v) to confer degrees on persons who have done independent research under prescribed conditions;
 - (vi) to provide for teaching specified courses or training for persons not being the students of the College, grant certificates and diplomas to such persons;
 - (vii) to affiliate or disaffiliate colleges in the prescribed manner;
 - (viii) to admit educational institutions to its privileges or withdraw such privileges from them in the prescribed manner;
 - (ix) to inspect colleges and other educational institutions affiliated or seeking affiliation with it;
 - (x) to accept the examinations passed or the periods of study spent at other college or places of learning, as equivalent to examinations or periods of study in the University or withdraw such acceptance;
 - (xi) to cooperate with other universities and / or public authorities in such manner and for such purposes as it may determine;

- (xii) to institute Professorships, Associate Professorships Assistant Professorships and Lectureships and nay other posts and to appoint persons thereto;
- (xiii) to create posts for research, extension, administration and for any other posts and appoint persons thereto;
- (xiv) to recognize selected members of the teaching staff of affiliated colleges and educational Institutions admitted to its privileges and such other persons as teachers as it may deem fit;
- (xv) to institute and award fellowships, scholarships, bursaries, medals and prizes in the prescribed manner;
- (xvi) to establish Teaching Department, colleges, faculties, institutes, centers of excellence, museums, and other centers of learning for the development of teaching and research and make such arrangements for their maintenance, management and administration, as it may determine;
- (xvii) to control the residence of the students of the University and the colleges, institute and maintain halls of residence and approve or license any place as hostel or lodging or students;
- (xviii) to supervise and control the discipline of the students of the University and colleges and promote the extracurricular and recreational activities of such students and made arrangements for promoting their health and general welfare;
- (xix) to take disciplinary action against, and Impose penalty on students in the prescribed manner;
- (xx) to demand, charge and receive such fees and other payments as it may determine;
- (xxi) to make provision for research and advisory services and with these objects to enter into arrangements with other Institutions or with public bodies under prescribed conditions;

- (xxii) to enter into, carry out, vary or cancel contracts;
- (xxiii) to receive and manage property transferred, and grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University, and invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contribution in such manner as it may deem fit;
- (xxiv) to provide for the printing and publication of research and other works; and
- (xxv) to do all such other acts or things, whether incidental to the power aforesaid or not, as may be necessary to further the objects of the University as a place of educations, learning and research, and as teaching, affiliating and examining body.

6. (1) Notwithstanding anything contained in any law, for the time being in force, the University shall have jurisdiction within the limit of its campus and in respect of colleges in such areas within the Province of Sindh as may be notified by Government: **Jurisdiction of the University.**

Provided that Government may, in consultation with the University, by general or special order modify the jurisdiction.

(2) No educational institution situated within the territorial limits of the University shall, save with the consent of the University and the sanction of Government, be associated in any way with or seek admission to the privileges of any other University.

(3) The University may admit to its privileges under prescribed conditions, an educational institution falling within the territorial limits of another university whether inside or outside Pakistan; provided that the consent of such other University is first obtained.

7. (1) The University shall be open to all persons of either sex and of whatever religion, race, caste, creed, class or colour and no person shall be denied the privileges of the University on the grounds only of sex, religion, race, caste, creed, class or colour: **University Open to all classes, creeds, etc.**

Provided that nothing in this section shall be deemed to prevent religious instruction being given to the students in their own religious faiths in such manner as may be prescribed.

(2) Government may issue guidelines and principles with respect to admission in the University including its constituent colleges and constituent institutions.

(3) The Academic Council shall frame admission policy in consonance with guidelines and principles.

8. (1) All recognized methods of teaching in various courses in the University or the colleges shall be conducted in the prescribed manner, and it may include lectures, tutorials, discussions, seminars, demonstrations as well as practical work in laboratories, hospitals, workshop and other methods of instruction. **Teaching at the University.**

(2) The teaching in any prescribed course in the University or colleges shall be organized by such Authority as may be prescribed.

(3) The courses and the curricular for teaching in the colleges shall be such as may be prescribed; provided that at the level of Bachelors degree, in all faculties, a discipline to be called the Islamic and Pakistan Studies Discipline shall be compulsory for Muslim students, and non-Muslim students shall in lieu of such discipline have option to offer Ethics and Pakistan Studies.

CHAPTER – III **OFFICER OF THE UNIVERSITY**

9. The following shall be the officers of the University:- **Officers of the University**
- (i) the Chancellor;
 - (ii) the Pro Chancellor;
 - (iii) the Vice Chancellor;
 - (iv) the Pro Vice-chancellor;
 - (v) the Deans;
 - (vi) the Principals of the constituent colleges;
 - (vii) the Directors;
 - (viii) the Chairman of teaching departments;
 - (ix) the Registrar;
 - (x) the Director Finance;
 - (xi) the Controller of Examinations;

- (xii) the Chief Accountant;
- (xiii) the Bursar;
- (xiv) the Resident Auditor;
- (xv) the Director Planning & Development;
- (xvi) Librarian;
- (xvii) and such other persons as may be prescribed by the Regulations to be the officers of the University.

10. (1) The Governor of Sindh shall be the Chancellor of the **Chancellor.**
University.

(2) The Chancellor shall, when present, preside at Convocation of the University.

(3) Every proposal to confer an honorary degree shall be subject to confirmation by the Chancellor.

11. If the Chief Minister is satisfied that the proceedings of any **Chief Minister.**
Authority are not in accordance with the provisions of this act, the statutes, the regulations, or the rules, he may, after calling upon such Authority to show cause why such proceedings should not be annulled, by order in writing, annul the proceedings.

(2) The Chief Minister shall have the power to assent to such statutes as are required to be submitted to him by the senate or withhold assent and refer them back to the senate for reconsideration.

(3) The Chief Minister may remove any person from the membership of any Authority if such person -

- (i) has become of unsound mind; or
- (ii) has been incapacitated to function as member of such Authority; or
- (iii) has been convicted by a court of law of an offence involving moral turpitude.

(4) The Chief Minister may, subject to the provisions of this Act, delegate all or any of the powers and functions of any Authority, officer or employee of the University at its main campus, to any authority, officer, employee or any other person at its additional

campus for the purpose of exercising such powers and performing such functions in relation to such additional campus, and for this propose the Chief Minister may create new posts or positions at the additional campus.

12. (1) The Chief Minister may cause an inspection or enquiry to be made in respect of any affairs or matter directly or in directly concerned with the University and shall, from time to time, appoint such person or more persons for of carrying out to conduct such inspection of - **Visitation.**

- (i) the university, its buildings, laboratories, libraries, museums, workshops and equipment;
- (ii) any institution college or hostel maintained or recognized by or affiliated to the University;
- (iii) the teaching and other work conducted by the University; and
- (iv) the conduct of examinations held by the University;

(2) The Chief Minister shall, in every such case aforesaid, give notice to the Syndicate of his intention to cause an inspection or enquiry to be made, and Syndicate shall be entitled to be represented there-at.

(3) The Chief Minister shall communicate to the Syndicate his views with regard to the results of such inspection or enquiry and shall, after ascertain the views thereon of the Syndicate, advice the Syndicate on the action to be taken.

(4) The Syndicate shall communicate to the Chief Minister such action, if any, as has been taken or may be proposed to be taken upon the results of the inspection or inquiry within such time as may be specified by the Chief Minister.

(5) Where the Syndicate does not, within a specified time, taken action to the satisfaction of the Chief Minister, the Chief Minister may, after considering any explanation furnished or representation made by the Syndicate, issue such direction as he thinks fir, and the Vice Chancellor shall comply with such directions.

13. (1) The Pro-Chancellor of the University shall be the Minister from Cabinet as may be nominated by the Chief Minister. **Pro-Chancellor.**
- (2) Should the Chancellor be incapacitated from acting as such due to absence or any other cause, the Pro-Chancellor shall exercise all the powers and perform all the duties of the Chancellor.
14. (1) There shall be a Vice Chancellor of the University who shall be an eminent academic qualified to be full Professor and shall be appointed by the Chief Minister for a period of four years which may be extended for one more term only on such terms and conditions as the Chief Minister may determine. **Vice-Chancellor.**
- (2) The Professional and Academic qualifications, experience and age for the post of Vice Chancellor shall be as such as may be determined by the Search Committee.
- (3) At any time when the office of the Vice Chancellor is vacant, or the Vice Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the Chief Minister shall make such arrangements for the performance of the duties of the Vice-Chancellor.
- (4) The Chief Minister shall, in case of allegations of gross misconduct, inefficiency, corruption, violation of budgetary provisions, moral turpitude, maladministration and mismanagement, remove the Vice Chancellor, on the basis of substantiated enquiry committee after giving him an opportunity of show cause notice against such removal.
- (5) The Vice Chancellor may avail leave with the permission of Chief Minister or any other authority duly authorized by the Chief Minister.
15. (1) The Vice Chancellor shall be the principal executive and academic officer of the University, and shall ensure that the provisions of this Act, the statutes, the regulations and the rules are faithfully observed in order to promote the general efficiency and good order of the University. He shall have all powers necessary for this purpose including administrative control over all officers, teachers and other employees of the University. **Powers and Duties of the Vice chancellor.**
- (2) The Vice Chancellor shall, in the absence of the Chancellor and Pro-Chancellor, preside at the Convocation of the University and the meetings of the Senate and shall, if present, preside at

the meetings of the Authorities of which he is the Chairman and be entitled to attend and preside at any meeting of any other Authority or body of the University.

(3) The Vice Chancellor may, in an emergency, which in his opinion requires immediate action, take such action as he may consider necessary and shall, as soon thereafter as possible, report his action to the officer, authority or other body which in the ordinary course, would have dealt with the matter.

(4) The Vice Chancellor shall also have the powers –

- i. to create and fill temporary posts for a period not exceeding six months;
- ii. to sanction all expenditure provided for in the approved budget, and to re-appropriate funds within the same major head of expenditure;
- iii. to sanction by re-appropriation an amount not exceeding two hundred thousand rupees for an unforeseen item not provided for in the budget, and report it to the Syndicate at the next meeting;
- iv. to appoint paper setters and examiners for all examinations of the University after receiving panels of names from the relevant authorities;
- v. to make such arrangements for the scrutiny of papers, marks and results as may be necessary;
- vi. to direct teachers, officers and other employees of the University to take up such assignments in connection with teaching, research, examination, administration and such other activities in the University as he may consider necessary for the purpose of University;
- vii. to delegate, subject to such conditions, if any, as may be prescribed, any of his powers under this Act to an officer or officers of the University;
- viii. to exercise general control supervision over the system of examination in the University;

- ix. to appoint employees of such categories in respect of which powers have been delegated to him by the Syndicate;
 - x. to exercise and perform such other powers and functions as may be prescribed; and
 - xi. to make appointments to the posts in all grades of the Basic Scales of pay up to grade 16 subject to approval of the competent authority.
16. (1) The Pro-Vice Chancellor shall be from amongst University Professors to be appointed by the Chief Minister for the main campus or of the additional campus, if any, or for both the campuses jointly or separately, on such terms and conditions and for such period not exceeding four years at time as may be determined by the Chief Minister. **Pro-Vice Chancellor.**
- (2) Where a Pro-Vice Chancellor is appointed under subsection,(1), he shall, notwithstanding anything contained in this Act, exercise such powers and perform such functions of the Vice Chancellor or such other powers and functions, in respect of the campus for which he is appointed, as the Chief Minister may delegate to him.
- (3) The Pro-Vice Chancellor, if appointed, shall be ex-officio member of the Senate, Syndicate and Academic Council for the matters pertaining to the campus to which he is appointed and shall be deemed to be included in the University and be an officer of the University under section 9.
17. (1) The Registrar shall be a whole-time officer of the University and shall be appointed by the Syndicate on the recommendations of the Selection Board, on such terms and conditions as it may determine. **Registrar.**
- (2) The Registrar shall –
- (a) hold office for a period of three years on the expiry of which he shall be eligible for re-appointment;
 - (b) be the custodian of the common seal and the academic records of the University;
 - (c) maintain a register of registered graduates in the prescribed manner;

- (d) conduct election of members to the various authorities in the prescribed manner; and
 - (e) perform such other duties as may be prescribed.
18. (1) The Director of Finance shall be a whole-time officer of the University and shall be appointed by Chief Minister from a panel of three candidates recommended by the Search Committee on such terms and conditions as it may determine. **Director of Finance.**
- (2) The Director Finance shall –
- (a) hold office for a period of three years and on the expiry of such period, he shall be eligible for reappointment;
 - (b) be the Chief Finance officer of the University;
 - (c) manage the property, finances and the investments of the University;
 - (d) prepare the annual and revised budget estimates of the University and present them to the Finance Committee, the Syndicate and the Senate;
 - (e) ensure that the funds of the University are expended for the purposes for which they are provided; an
 - (f) perform such other duties as may be prescribed.
- (3) The experience as well as professional and academic qualifications for the post of Director of Finance shall be such as may be determined by the Search Committee.
- (4) The Director of Finance shall be assisted by the Chief Accountant, Bursar and the Resident Auditor.
19. The Controller of Examinations shall be a whole time officer of the University and shall be appointed by Syndicate on the recommendations of the Selection Board on such terms and conditions as it may determine. He shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed. **Controller of Examinations.**

28. (1) The Syndicate shall be the executive body of the University and shall subject to the provisions of this Act and the statutes, exercise general supervision over the affairs and the property of the University. **Power and duties of the Syndicate.**
- (2) Without prejudice to the generality of the foregoing powers, and subject to the provisions of this Act and the Statutes, the Syndicate shall have the powers—
- (a) to hold, control and administer the property and funds of the University;
 - (b) to govern and regulate, with due regard to the advice of the Finance and planning Committee in this behalf, the finances, accounts and investments of the University and for that purpose, to appoint such agents as it may think fit;
 - (c) to consider the annual report, the annual and revised budget estimates and to advise the Senate thereon, and to re-appropriate funds from one major head of expenditure to another;
 - (d) to transfer and accept transfer of movable or immovable property on behalf of the University;
 - (e) to enter into, vary, carry out and cancel contracts on behalf of the University;
 - (f) to cause proper books of account to be kept for all sums of money received and expended by the University and for the assets and liabilities of the University;
 - (g) to invest any money belonging to the University including any unapplied income in any of the securities described in section 20 of the Trusts Act, 1882 (Act II of 1882), or in the purchase of immovable property or in such other manner, as it may determine, with the like power of varying such investments;
 - (h) to receive and manage any property transferred, and grants, bequests, trusts, gifts, donations, endowments and other contributions made to the University;

- (i) to administer any funds placed at the disposal of the University for specified purposes;
- (j) to determine the form, provide for the custody and regulate the use of the common seal of the University;

- (l) to establish and maintain halls of residence and hostels or approve or license hostels or lodgings for the residence of students;

- (o) to arrange for the inspection of colleges and the Teaching Departments;

(2) The draft of Statutes shall be proposed by the Syndicate to the Senate which may approve it or pass it with such modifications as the Senate may think fit, or may refer it back to the Syndicate for reconsideration, or may reject it:

Provided that the Syndicate shall not propose draft of Statutes affecting the constitution or powers of any Authority of the University, until such Authority has been given an opportunity of expressing an opinion in writing upon the proposal:

Provided further that the draft of Statutes concerning any of the matters in clause (a) of sub-section (1) shall be forwarded to the Chief Minister and shall not be effective until it has been approved by the Chief Minister.

34. (1) Subject to the provisions of this Act and the statutes, **Regulations.** regulations may be made for all or any of the following matters, namely:-

- (a) the courses of studies for degrees, diplomas and certificates of the University;
- (b) the courses of study for degrees, diplomas and certificates of the University;
- (c) the manner in which the recognized teaching referred to in section 8 shall be organized and conducted;
- (d) the admission of students to the University;
- (e) the conditions under which students shall be admitted to the courses and the examinations of the University and shall become eligible for the award of degrees, diplomas and certificates;

- (g) fees and other charges to be paid by students for admission to the courses of study and the examinations of the University;

- (i) conditions of residence of the students of the University or the colleges, including the levying of fees for residence in halls of residence and hostels;
- (j) the approval and licensing of hostels and lodgings;
- (k) conditions under which a person should carry on independent research to entitle him to a degree;
- (l) the institution of fellowships, scholarships, exhibitions, medals and prizes;
- (m) the institution of stipends and free and half-free studentships;
- (n) the academic costume;
- (o) the use of the Library;
- (p) the formation of Teaching Departments and Boards of Studies; and
- (q) all other matters which by this Act and Statutes are to be or may be prescribed by Regulations.

(2) The Regulations shall be prepared by the Academic Council and shall be submitted to the Syndicate which may approve them or with-hold approval or refer them back to the Academic Council for reconsideration. A Regulation prepared by the Academic Council shall not be valid, unless it receives the approval of the Syndicate.

35. (1) The Authorities and the other bodies of the University may make rules consistent with this Act, statutes and the regulations, to regulate the conduct of their business and the time and place of meetings and related matters: **Rules.**
 Provided that the Syndicate may direct the amendment or the

36. The procedure for adding to, amending or repealing the statutes and the regulations shall be the same as that prescribed respectively for framing or making statutes and regulations. **Amendment and repeal of statutes and regulations.**

CHAPTER-VI

AFFILIATION OF EDUCATIONAL INSTITUTIONS TO THE UNVIERSIT

37. (1) An educational institution applying for affiliation to the University shall make an application to the University and shall satisfy it - **Affiliation.**
- (i) that the educational institution is under the management of the Government or of a regularly constituted governing body;
 - (ii) that the financial resources of the educational institution are sufficient to enable it to make due provision for its continued maintenance and efficient working;
 - (iii) that the strength and qualifications of the teaching and other staff, and the terms and conditions of their service, are adequate to make due provision for the courses of instruction, teaching or training to be undertaken by the educational institution;
 - (iv) that the educational institution has framed proper rules regarding the efficiency and discipline of its staff and other employees;
 - (v) that the building in which the educational institution is to be located is suitable, and that provision will be made inconformity with the statutes and the regulations for the residence of students, not residing with their parents or

guardians, in the hostels established and maintained by the educational institution or in hostels or lodgings approved by it, and the supervision and physical and general welfare of students;

- (vi) that provision has been made for Library and adequate library services;
- (vii) that where affiliation is sought in any branch of experimental sciences, due arrangements have been made for imparting instruction in that branch of science in a properly equipped laboratory, museum and other places of practical work;
- (viii) that due provision will, so far as circumstances may permit, be made for the residence of Principal and members of the teaching staff in or near the college or the place provided for the residence of students; and
- (ix) that the affiliation of the educational institution, having regard to the provision which may have been made for students by another educational institution in its neighborhood, will not be injurious to the interests of education or discipline.

(2) The application shall further contain an undertaking that after the educational institution is affiliated any transference of, and changes in the management and in the teaching staff shall be forthwith reported to the University, and that the teaching staff shall possess such qualifications as are or may be prescribed.

(3) The procedure to be followed in disposing of an application for the affiliation of an educational institution shall be such as may be prescribed.

(4) The Syndicate may, on the recommendation of the Affiliation Committee, grant or refuse affiliation to an educational institution:

Provided that affiliation shall not be refused, unless the

- (ii) control and administer the property of the institution or college;
- (iii) manage and regulate the funds, finances, assets and investments of the institution or college;
- (iv) maintain the accounts of the institution or college in the prescribed form and get such accounts audited in the prescribed manner; and
- (v) appoint teachers and other employees of the institution or college and have the power to take disciplinary action against them.

CHAPTER VI UNIVERSITY FUND

43. There shall be fund for the University to be called the University Fund to which shall be credited all moneys received by the University from fees, donations, trusts, bequests, endowments, contributions, grants and other sources. **University Fund.**
44. (1) The accounts of the University shall be maintained in such form and in such manner as may be prescribed. **Audit and Accounts.**
- (2) No expenditure shall be made from the funds of the University unless a bill for its payment has, in accordance with the statutes, been audited by the Resident Auditor and the payment is included in the approved budget of the University.
- (3) The accounts of the University shall, in the prescribed manner, be audited once a year by the Auditor appointed by the Syndicate.
- (4) The annual statement of the accounts of the University signed by the Director of Finance and the Resident Auditor shall

be submitted to Government within six months of closing of the financial year.

(5) The accounts of the University together with audit objections, if any, and the observations of the Government Auditor and the Director of Finance shall, in the prescribed manner, be presented to the Syndicate.

CHAPTER-VII

GENERAL PROVISIONS

45. An officer, teacher or other employee of the University shall retire from the service of the University - **Retirement from service.**

- (i) on such date, after he has completed twenty five years' service qualifying for pension or other retirement benefits, as the competent authority may direct:

Provided that no employee shall be retired unless he has been informed in writing of the grounds of the action proposed to be taken against him and has been given reasonable opportunity of showing cause against that action; or

- (ii) where no direction is given under clause (i), on the completion of sixty years age.

Explanation.- In this section "competent authority" means the appointing authority or a person duly authorized by the appointing authority in that behalf, not being a person lower in rank to the officer, teacher or other employee concerned.

46. Except as otherwise provided in this Act, no officer, teacher or other employee of the University holding a permanent post shall be reduced in rank, or removed or compulsorily retired from service, unless he has been given reasonable opportunity of showing cause against the action proposed to be taken against him. **Opportunity to show cause.**

47. (1) Where an order is passed punishing any officer (other than the Vice Chancellor), teacher or other employee of the University or altering or interpreting to his disadvantage the prescribed terms or conditions of his service, he shall, where the order is passed by the Vice Chancellor or any other officer or teacher of the University, have the right to appeal to the Syndicate against the order, and where the order is made by the Syndicate, have the right to apply to that authority for review of that order. **Appeal to and review by the Syndicate.**

(2) The appeal or application for review shall be submitted to the Vice Chancellor and he shall lay it before the Syndicate with his

views along with the record of the case.

(3) No order in appeal or review shall be made unless the appellant or the applicant, as the case may be, has been given an opportunity of being heard.

48. (1) The University shall constitute for the benefit of its officers, teachers and other employees in such manner and subject to such conditions as may be prescribed, such pension, insurance, gratuity, provident funds and benevolent fund scheme as it may deem fit. **Pension Insurance, Gratuity, Provident Fund and Benevolent Fund.**
- (2) Where any provident fund has been constituted under this Act, the provisions of the Provident Funds Act, 1925 (Act No.XIX of 1925) shall apply to such funds as if it were the Government Provident Fund.
49. (1) When a member of a newly constituted Authority is elected, appointed or nominated, his term of office, as fixed under this Act, shall commence from such date as may be prescribed. **Commencement of term of office of members of Authority.**
- (2) Nothing in sub-section (1) shall affect the provisions of section 51.
- (3) Where a member who has been nominated or elected to any Authority fails to attend three meetings of the Authority consecutively, he shall cease to be the member.
- Where a member who has accepted any assignment or for any such other reason remains absent from the University for a period of not less than six months, he shall be deemed to have resigned and vacated his seat.
50. Any casual vacancy among the elected, appointed or nominated members of any Authority shall be filled, as soon as conveniently may be, by the person or persons or the body who elected, appointed or nominated the member whose place has become vacant and the person elected, appointed or nominated to vacancy, shall be a member of such Authority for the residue of the term for which the person whose place he fills would have been a member. **Filling of casual vacancies in Authorities.**
51. Where there is a void in the constitution of an Authority as constituted by this Act, because of the abolition of a specified office under Government or because an organization, institution or other body outside the University has been dissolved or has ceased to function or because of some other similar reason, the void shall be filled in such manner as the Chief Minister may direct. **Voids in the constitution of the Authorities.**
52. If a question arises whether any person is eligible to become or continue as member of any Authority, the matter shall be **Dispute about membership of**

- referred to a committee consisting of the Vice Chancellor and the Judge of the High Court, and the senior-most dean who is the member of the Syndicate, and the decision of the committee shall be final and binding. **Authorities.**
53. No act, resolution or decision of any Authority shall be invalid be reason of any vacancy on the Authority doing, passing, or making it or by reason of any want of qualification or invalidity in the election, appointment or nomination of any defacto member of the Authority, whether present or absent. **Proceedings of Authorities of not invalidated by vacancies.**
54. Notwithstanding anything contrary contained in this Act, the statutes set out in the Schedule to this Act, shall be deemed to be the statues framed under section 33 and shall continue to remain in force until they are amended or replaced by new statutes framed in accordance with the provisions of this Act. **First Statutes.**

No suit or legal proceedings shall lie against Government, the University or any Authority, officer or employee of Government or University or any person in respect of anything which is done or purported to have been done in good faith or is intended to or has been done under this Act. **Indemnity.**
57. (1) Notwithstanding anything contained hereinbefore— **Powers to require officers, teachers or employees to serve under any organization.**
- (a) any officer, teacher or other employee of the University shall as the Chief Minister may in the public interest direct, serve in any post under Government or any other University or an educational or research institution; provided that in the case of a teacher, the Syndicate shall be consulted before issuing the direction;
 - (b) the Chief Minister may, in the public interest, direct, any post in the University to be filled by appointing any employee of Government or any other University or an educational or research institution; provided that in the case of a teacher, the Selection Board shall be consulted before filling in the post.
- (2) Where any appointment or transfer has been made under this section, the terms and conditions of service of the appointee or

transferee shall not be less favorable than those admissible to him immediately before such appointment or transfer and he shall be entitled to all benefits of his past service.

(2) The Boards of Faculties in Arts, Science, Business Administration and shall each consist of –

- (i) the Dean;

- (iii) one Lecturer, one Assistant Professor and one Associate Professor, each to be appointed by rotation in order or seniority from each Department; and
- (iv) three Teachers to be nominated by the Academic Council by reason of their specialized knowledge of the subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the Faculty.

(3) The Board of Faculties in Education and Law shall each consist of –

- (i) the Dean;
- (ii) the Professors;
- (iii) two members of each Board of Studies, comprised in the Faculty, to be nominated by the Board of Studies concerned; and
- (iv) three teachers to be nominated by the Academic Council by reason of their specialized knowledge of subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council, important bearing on the subjects assigned to the Faculty.

(4) The members mentioned in sub-clauses (iii) and (iv) of clause 2 and 3 shall hold office for three years.

(5) The quorum for a meeting of the Board of a Faculty shall be one-half of the total number of members, a fraction being counted as one.

(6) The Board of each Faculty shall, subject to the general control of the Academic Council and the Syndicate, have the powers –

- (a) to coordinate the teaching and research work in the subject assigned to the Faculty;
- (b) to scrutinize the recommendations of the Board of Studies comprised in the Faculty, on the appointment of paper setters and examiners, except for research examiners and forward them to the Vice Chancellor;
- (c) to consider any other academic matter relating to the Faculty and to report thereon to the Academic Council; and
- (d) to perform such other functions as may be prescribed.

2. (1) There shall be a Dean of each Faculty who shall be the **Dean.**
Chairman and convener of the Board of Faculty.

(2) The Dean of each Faculty shall be appointed by the Chief Minister on the recommendations of the Vice Chancellor from amongst the three most senior Professors in the Faculty for a period of three years.

(3) The Dean shall present candidates for admission to degree, except honorary degrees, in the courses falling within the purview of the Faculty.

(4) The Dean shall exercise such other powers and perform such other duties as may be prescribed.

3. (1) There shall be a Teaching Department for each subject or a group of subjects as may be prescribed by regulations and each Teaching Department shall be headed by a Chairman. **Teaching Department.**

(2) The Chairman of the Teaching Department shall be

appointed by the Syndicate on the recommendations of the Vice Chancellor from amongst three most senior Professors or Associate Professors of the Department for a period of three years:

Provided that where there is no Professor or Associate in a Department, it shall be looked after by the Dean of the Faculty with the assistance of the most senior teacher of the Department.

(3) The Chairman of the Teaching Department shall plan, organize and supervise the work of the Department in accordance with the provisions of this Act and shall be responsible to the Dean of the Faculty in which his Department is comprised for the work of his Department.

4. (1) There shall be a separate Board of Studies for each subject or group of subjects, as may be prescribed by the regulations. **Boards of Studies.**

(2) Each Board of Studies shall consist of-

- (a) the Chairman of the Teaching Department;
- (b) all Professors and Associate Professors in the Teaching Department concerned;
- (c) two Assistant Professors and one lecturer to be appointed by rotation in order of seniority from the Department concerned;
- (d) two teachers other than the teachers to be appointed by the Syndicate. The number will be determined by the Syndicate according to the needs of each Board;
- (e) one expert to be appointed by the Vice-Chancellor; and
- (f) one representative of the teachers of each affiliated college teaching at graduate and postgraduate levels in that subject to be nominated by the Academic Council.

(3) The term of office of members of the Board of Studies other than ex-officio members shall be three years.

(4) The quorum for meetings of the Board of Studies shall be one-half of the total number of members, a fraction being counted as one.

(5) The Chairman of the Teaching Department concerned shall be the Chairman and convener of the Board of Studies. Where in respect of a subject there is no Teaching Department, the Chairman shall be appointed by the Syndicate.

(6) The functions of the Board of Studies shall be –

- (a) to advise the Authorities on all academic matters connected with instruction, research and examination in the subject or subjects concerned;
- (b) to propose curricula and syllabi for all degree, diploma and certificate courses in the subject or subjects concerned;
- (c) to suggest a panel of names of paper-setters and examiners in the subject or subjects concerned; and
- (d) to perform such other functions as may be prescribed by regulations.

5. (1) The Advanced Studies and Research Board shall consist of – **Advanced Studies and Research Board.**
- (i) the Vice Chancellor (Chairman);
 - (ii) the Deans;
 - (iii) three University Professors other than Deans to be appointed by the Syndicate;
 - (iv) three University Teachers having research qualifications and experience to be appointed by the Academic Council; and
 - (v) the Professors Emeritus.

(2) The term of office of members of the Advanced Studies and Research Board other than ex-officio members shall be three years.

(3) The quorum for a meeting of the Advanced Studies and Research Board shall be one-half of the total number of members, a fraction being counted as one.

(4) The functions of the Advanced Studies and Research Board shall be –

- (a) to advise the Authorities on all matters connected with the promotion of advanced studies and research in the University;
- (b) to consider and report to the Authorities on the institution of research degrees in the University;
- (c) to propose regulations regarding the award of research degrees;
- (d) to appoint supervisors for research students and to determine the subjects of their thesis;
- (e) to recommend panels of names of paper setters and examiners for research examinations after considering the proposals of the Board of Studies in this behalf; and
- (f) to perform such other functions as may be prescribed by the statutes.

6. (1) The Selection Board shall consist of –

- (i) the Vice Chancellor (Chairperson);
- (ii) the Chairman, or a member of the Sindh Public Service Commission to be appointed by the Chairman;
- (iii) the Secretary Universities and Boards;

(4) No member of the Selection Board who is a candidate for the post to which appointment is to be made shall take part in the proceeding of the Selection Board.

(5) In selecting candidates for the posts of Professors and Associate Professors, the Selection Board shall co-opt or consult three experts in the subject concerned, and in selecting candidates for other teaching posts, two experts in the subject concerned, to be nominated by the Vice Chancellor, from a standing list of experts for each subject approved by the Syndicate on the recommendation of the Selection Board and revised from time to time.

7. (1) The Selection Board shall consider the applications for teaching and other posts received in response to an advertisement and shall recommend to the Syndicate the names of suitable candidates for appointment to such posts. **Functions of Selection Board.**

(2) The Selection Board may recommend the grant of a higher initial pay in a suitable case for reasons to be recorded in writing.

(3) The Selection Board may recommend to the Syndicate the appointment of an eminently qualified person to a Professorship in the University on the terms and conditions other than those prescribed.

(4) The Selection Board shall consider all cases of promotion of officers of the University and recommend to the Syndicate the names of suitable candidates as may be prescribed.

(5) In the event of an unresolved difference of opinion between the Selection Board and the Syndicate, the matter shall be referred to the Chief Minister whose decision shall be final.

8. (1) There shall be Finance and Planning Committee consisting of - **Finance and Planning Committee.**
- (a) the Vice-Chancellor (Chairperson);
 - (b) one member of the Senate to be appointed by the Senate;
 - (c) one member of the Syndicate to be appointed by the Syndicate;

(5) An officer of the University to be designated by the Vice Chancellor for this purpose shall act as the Secretary of the Committee.

(6) The functions of the Affiliation Committee shall be –

- (a) to inspect the educational institutions seeking affiliation with or admission to the privileges of the University and to advise the Academic Council thereon;

- (ii) to perform such other functions as may be prescribed by the regulations.
