<p>CHAPTER-I PRELIMINARY</p>	
<p>1. (1) This Act may be called the ILMA University Act, 2016.</p> <p>(2) It shall come into force at once.</p>	<p>Short title and commencement.</p>
<p>2. In this Act, unless there is anything repugnant in the subject or context:-</p> <p>(a) “Academic Council” means the Academic Council of the University;</p> <p>(b) “Affiliated Institution or College” means an educational institution or college affiliated to the University but not maintained or administered by it;</p> <p>(c) “Authority” means any of the Authorities of the University specified in section 16;</p> <p>(d) “Board” means the Board of Governors of the University;</p> <p>(e) “Chairman” means the Chairman of the Board;</p> <p>(f) “Chancellor” means the chancellor of the University;</p> <p>(g) “College” means a college and includes an institution in which arrangement exist for imparting instructions in general, technical professional education or other disciplines of higher learning and such other subjects as may be prescribed;</p> <p>(h) “Constituent or institution college” means an institution or college maintained and administered by the University;</p> <p>(i) “Dean” means the Head of Faculty;</p> <p>(j) “Director” means the head of a teaching or administrative division of an institute;</p> <p>(k) “Faculty” means a Faculty of the University;</p> <p>(l) “Government” means the Government of Sindh;</p> <p>(m) “Head” mean the Head of the Teaching Department;</p> <p>(n) “HEC”, means Higher Education Commission, Government of Pakistan;</p>	<p>Definitions.</p>

<p>(o) “Officer” means and of the officers of the university specified in section 5;</p> <p>(p) “Patron” means the Patron of the University;</p> <p>(q) “Prescribed” means prescribed by status, regulations or rules;</p> <p>(r) “Pro-Vice Chancellor” means the Pro-Vice Chancellor of the University;</p> <p>(s) “Professor Emeritus” means a retired professor working in the University in an honorary capacity;</p> <p>(t) “Registrar” means the Registrar of the University;</p> <p>(u) “Society” means the Global Educational consultants Society registered under the Society Registration Act, 1860 vide registration No: KAR No: 195 of 2001 dated 06-10-2000;</p> <p>(v) “Statutes”, “regulations” and “rules” means respectively the statutes, regulations and rules made under this Act;</p> <p>(w) “Teaching Department” means a Teaching Department of the University;</p> <p>(x) “Teacher” means whole time teacher engaged as Professor, Associate Professor, Assistant Professor, Lecturer and such other persons as may be declared to be the Teachers;</p> <p style="padding-left: 40px;">(xi) “University” means the ILMA University established under this Act;</p> <p style="padding-left: 40px;">(xii) “Vice Chancellor” means the Vice Chancellor of the University.</p>	
<p>3. (1) There shall be established a University to be called the ILMA University, consisting of the Chairman, Chancellor, the Vice Chancellor, Pro-Vice Chancellor, the Deans, the Head of the Teaching Departments and Member of the Board, the Members of the Academic Council and such other Officers as may be prescribed.</p> <p>(2) The University shall be a body corporate by the name of the ILMA University, owned, managed and administered by the Society and shall have perpetual succession and a common seal and may sue and be sued by the said name.</p> <p>(3) The University shall be competent to acquire and hold property, both movable and immovable, to lease, sell or otherwise transfer any movable and immovable property which may have become vested in or been acquired by it.</p> <p>(4) The University shall be open to all persons of sex or whatever religion race, creed, color or domicile who are academically</p>	<p>Incorporation.</p>

<p>qualified for admission to the courses of study offered by the University and no such person shall be denied the privilege on the ground only of sex, religion, creed, race, class, color or domicile.</p> <p>(5) The moral and ethical codes employed on the University campus, affiliated colleges or institutes and the constituent institutions will be based on and derived from the cardinal principles and the guidance embodied in the Holy Quran and the Sunnah of the Prophet (SAWW).</p> <p>(6) The University shall take measures to setup campus or campuses anywhere in Sindh.</p>	
<p>4. (1) The University shall have the powers subject to the instructions of Government as issued from time to time, to-</p> <p>(a) provide for instructions in such branches of learning as it may deem fit, and to make provision for the advancement and dissemination of knowledge in such manner as it may determine; provided that the faculty of medicine shall be established as per requirement of the Pakistan Medical and Dental Council;</p> <p>(b) Affiliate itself or associate with other institutions and establish faculties and the Teaching Departments to discharge its functions and responsibilities for the betterment of education;</p> <p>(c) Prescribe courses of studies and curricula;</p> <p>(d) Admit students and hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and the persons who have been admitted to and have passed its examinations under prescribed conditions;</p> <p>(e) Confer honorary degrees or other distinctions on approved persons in the manner as may be prescribed;</p> <p>(f)</p>	<p>Powers and Functions of the University.</p>
